OFFICE ORDER

The State Election Commission, Arunachal Pradesh has announced the schedule of General Elections to the Panchayati Raj institutions (except 7 Tirbin Anchal Samiti of West Siang District) and Municipal Elections of Itanagar & Pasighat Municipalities in Arunachal Pradesh. With this announcement, the Model Code of Conduct has come into force and various instructions have already been issued by this office to enforce the same. With a view to ensuring better enforcement of the code and regulating various stages of direct recruitment by the departments and the Service Commission, the following instructions are specifically issued for due compliance :-

- i) There shall be no fresh creation of posts, no contract /adhoc / functional /officiating appointments of any kind by any department/office in this administration;
- ii) No compassionate appointments shall be made till the conclusion of the election process;
- iii) Where written examinations have already been held by any department or by the Service Commission or any other Departments, the evaluation of the papers should be stopped and if evaluation is in progress, it should be continued but announcement of the result should be withheld.
- iv) In the case of examination dates that have already been notified by the Service Commission the examination should be conducted but valuation should not be done. The answer papers should be sealed and kept in the custody of the heads of departments and in the case of the Commission, under the safe custody of the Secretary to the Commission.
- v) In the case of interviews that are yet to be held, they should be postponed till the process of election is completed and where interviews are already over, the publication of results should be deferred. Where interviews have already commenced and are in progress as per schedule, the same should be continued and completed but the publication of results should be deferred. The records in both the cases have to be kept in sealed cover in the personal custody of the head of Departments, and by the Secretary in case of the Service Commission. Due care and caution should be taken to ensure that the same are not tampered with.

2. The above instructions are specific and should be strictly and scrupulously followed, and in case of violation of these instructions the officer concerned will be personally held responsible and would expose himself to appropriate action.

3. These instructions are also applicable to all Corporations/Statutory Bodies/Commissions/Undertakings etc.


