

Dated Itanagar, the 19<sup>th</sup> April'2013

In Order No. AP/SEC- 21/2002 Dated Itanagar the 17<sup>th</sup> April 2013 regarding instructions on misuse of vehicles during election period the following words will be added in sub-para of Para 3 in the first sentence. Now, Sub-para of Para 3 shall be read as under :

**The above restrictions shall not apply in the case of Chief Minister, Speaker and Deputy Speaker, MPs of Rajya Sabha and Lok Sabha and such other dignitaries visiting the states from other states. It is, however, clarified that such exceptions shall not be made in respect of any Ministers or Parliamentary Secretaries.**
